### UK Changes to requirements

UKWF

- The Government has issued a statement stating its intention to permit the indefinite use of the CE mark
- This was a press announcement, and we have no further information.
- We have been led to believe that legislation will be issued in the first quarter of 2024
- Reminder of the legislation as of today:
  - Up to the 31<sup>st</sup> December 2024 you can use a CE mark and an EU notified body- there are no changes to requirements
  - Between 1<sup>st</sup> January 2025 and 31<sup>st</sup> December 2027 must have a UKCA mark either on the instrument or on accompanying documents- but this can use an EU27 type examination and an EU module D certificate



# UK Changes to requirements – what could this mean?



- For first placing on the market, you can use a CE mark with an EU27 type examination and module D
- You must still have a UK approved body for re-qualification of NAWI's
  - SGS
  - NSAI
  - NMI
  - UKMB
- You must still have a S11 A certificate for re-qualification of AWI's which can be obtained via the same approved bodies



# UK Changes to requirements – what could this mean?

UKWF

- If you are a business with existing EU type examinations, it could be of use to you
- You will not need to have corresponding UKCA certificate
- If you are a business that does not have your own type examinations:
  - Probably easier to us a UK approved body for any initial verifications.
  - Will need to use a UKCA mark and can use EU27 type examinations
  - Will be able to do re-qualifications and only have one approved body
  - If you use module F (Trading Standards) the instruments will need to be marked with a UKCA mark







- It has recently become apparent that you MUST have the authority to undertake re-qualification clearly on your module D certificate
- This will enable you to have unique identifying number for for re –qualification
- There seem to be several businesses that do not have the unique identifier.
- Please check your module D certificate to ensure that it is clear on the certificate
- If not, make sure your module D body is aware of the need

- The new Machinery Directive planned to be published June 2023 and implemented January 2027
- Increased legal certainty, uniform application (e.g. substantial modification)
- Integration of Artificial Intelligence related provisions for safety functions
- Integration of Cyber Safety related provisions for safety control systems and compliance related software and data
- Autonomous and remote-controlled machinery
- Digitalisation of instructions for use, assembly instructions and EU



## **EU Changes**



Cyber Resilience Act

#### Access the Cyber Resilience Act in all EU official languages

- Ensure that manufacturers improve the security of products with digital elements since the design and development phase and throughout the whole life cycle;
- Ensure a coherent cybersecurity framework, facilitating compliance for hardware and software producers;
- Enhance the transparency of security properties of products with digital elements, and
- Enable businesses and consumers to use products with digital elements securely.
- CECIP are working hard to ensure that this will not create more obligations above and beyond those in the existing requirements and WELMEC Guides







- Working on the continuing changes to the NAWI Directive and the MID
- Will be a questionnaire published which CECIP and the UKWF will complete
- Important as it will reflect future GB regulation and the question of divergence
- Working on the review of the R76
- Slow process but it is likely that final draft will be March next year
- Unlikely to be many major changes



#### **UKWF Work**



- Have been working on a policy document for metrology for the future in partnership with CTSI
