The Retained EU Law Bill and its implications



With the UK still negotiating the process of Brexit, there remain question marks over the future of regulation of our industry. The UKWF has been engaging fully with the Retained EU Law Bill as it progresses through the UK Parliament's legislative process. This Bill has significant implications on the future regulatory framework for legal metrology.

What is the EU Retained Law Bill?

The EU Retained Law (REUL) Bill is a piece of legislation that the Government has introduced that will remove all EU Retained Law from the UK's statute book, with the intention that it will be replaced with UK law. It is viewed by Government as the final piece of the Brexit puzzle – decoupling all UK law from European law. At time of writing, it is passing through the House of Lords public bill stages, and will return the House of Commons for final stages later in March.

What does it mean for us?

The regulatory standards imposed on the UK's weighing industry are based on European law. After Brexit, they became retained EU law and remained in place. However, the REUL Bill currently includes a sunset clause meaning that on 31st December 2023, all retained EU law will cease to be in force. This means the Government's Office for Product Safety and Standards (OPSS) has until the end of this year to replace the retained EU regulatory system for legal metrology with a new UK system.

Why is this an issue?

The REUL Bill affects over 4000 pieces of UK regulation and legislation. While the natural consequence of Brexit is that these will need to be replaced with UK-specific law, there is significant concern that the sunset clause of 31st December means that Government departments will simply not have time to adopt replacement regulations before retained law is removed. If OPSS has not adopted a new regulatory framework for legal metrology by 1st January 2024, there will be a regulatory vacuum for the weighing industry which risks allowing inaccurate, unsafe products and systems to enter the market.

What is the UKWF doing about this?

Over recent months, the UKWF has working to promote understanding of the implications of the REUL Bill for our industry, and campaign to remove the sunset clause, and allow sufficient time for Government departments to fully consider, and consult with industry experts on, what the new regulatory framework should look like.

The UKWF has undertaken the following activities to mitigate the risk of the removal of the UK's regulatory framework for legal metrology:

- Joined the CTSI's Safeguarding our Standards campaign, which highlights the value of good regulation
- Produced our own briefing paper outlining why high standards in weights and measures supports
 patient safety, consumer rights and safety, industrial and transport safety, government revenue
 collection and a robust UK weighing industry and sent out to members of the House of Lords
- Engaged with OPSS to try and find out what support we can offer

Between the 1st 2025 and the end of 2027 you must use the UKCA mark, but this can be with EU type approvals and EU self-verification certification. As soon as we know how the recent announcement with regard to Northern Ireland effects the use of the CE mark and the UKCA in that part of the UK, we will let you know

We know that regulations are only useful if they are properly understood by their enforcers. This is why I am so excited by the work we are doing to grow our partnership with CTSI. At the AGM, we'll be outlining how we propose to support CTSI in ensuring their officers get the training they need to carry out effective inspections.

Last month I led a technical webinar on the Packaged Goods Regulations. If you missed out, my slides are available on the UKWF website. The next webinar is scheduled for May. Please email me if is a particular topic you'd like me to cover.

I'm looking forward to catching up with many of you at the AGM in March and thank you for your support of the UKWF.
