# **UKWF and Weighing Industry News**

#### 1. New UKWF President

Following the AGM back in April, Graham Spink has now settled in as our new President and has hit the ground running during what has been a challenging time for our industry.

Graham has worked in the weighing industry for more than 20 years since starting as an apprentice at AWM in 1997. He took a short hiatus from weighing to gain a Physics degree at Edinburgh University before returning to become AWM Sales Manager in 2005. Graham was then appointed Managing Director in 2013.

There really isn't an area of weighing that Graham hasn't worked in or overseen during his time at AWM, including repairs, calibrations, hardware design, software project management, ISO, NAWI verifications, and the day to day management of the business.

#### 3. New UKWF Board Member

Nick has understandably resigned his position on the UKWF Board of Directors. We are pleased to share that Mark Clifford will now join the Board in Nick's place and we look forward to working with him to implement the strategic plan for the coming year.

Mark Clifford is the New Business Account Manager UK & Ireland, of Minebea Intec, and has been co-opted to the board with his position to be formalised at the next AGM.

He is a CNC toolmaker by trade, and spent 10 years in dimensional metrology specialising in reverse engineering and 3D printing, mainly in aerospace and automotive. He moved to mass metrology and the Weighing Industry in 2004, spending 4 years learning the trade at Sartorius Industrial. He moved to Herbert Industrial in 2008 and expanded his knowledge to include weigh price labelers, and then moved to Bizerba in 2010 to launch their inspection products into the UK market place. In 2018 he moved to Minbea Intec.

#### 4. New Chair of UKWF Marketing Group

Following the member feedback requested in the President's welcome letter, the board have appointed a Marketing Group to enhance the UKWF's profile and make us the go to organisation for Legal Metrology in the UK. They have appointed Tom Marren of Coventry Scale Company as the chair of this group to implement the board's plans and provide feedback on the group's progress.

Since then he has been instrumental in revamping the company's brand strategy, which has seen the business grow by 45%. # **Technical Updates**

### 1. Regulation 2019/2021 - Eco Design Requirements for Displays

The requirements for this new regulation have been issued and full details are available online here.

Some of the main requirements mentioned are:

- a) Energy-efficiency requirements during use, off mode and standby mode (Annex 1: A, B & C)
- b) Material efficiency requirements (Annex 1: D):
  - Batteries should be easily removed
  - Dismantling information of components should be easily available for users
  - End of life information available
  - Mark all plastic components above 50 g
  - Additional marking for component containing flame retardants
  - Indicate if cadmium is included
  - Halogenated flame retardants not allowed
- Spare parts for components such as internal power supply and capacitors available for at least 7 years
- These spare parts should be easy to be changed and information on ordering them easily available
- Repair and maintenance information should be made available for professional repairers
- Professional repairers can be asked for registration proof of competence, insurance and fees
- c) Information availability requirements (Annex 1: E)

- Software updates available for at least 8 years
- Information on software updates, availability spare parts and product support on product information

sheet

- Conformity assessment: Self declaration
